Steve Hopkins- (regarding cost for turf field) \$8.25 per child. School District same as Municipal charges. There is a clubhouse to be built at Brooks. Possibility of recutting lower brooks to accommodate super 8's. Possibility of merging PRYSA-School Board.

DDC pay will be 75% enrollment fees, 25% to youth soccer. Cost for PRYSA players \$125.00 other BC Soccer members \$150.00. Coaches helping out with DDC will receive credit towards coaching tickets. DDC will follow BC Soccer curriculum.
